PUBLIC HEARING – LOCAL LAW 1 of 2018 <u>A LOCAL LAW REPEALING CERTAN</u> PROVISIONS OF THE DOG CONTROL LAW

TOWN BOARD COMMENTS

Background and justification

Supervisor Cammarata shared a letter from Sheriff Bower explaining the County's decision to encourage the Towns to adopt the county-wide law for dog control.

Overview and opinion

It is the unanimous opinion of the Town Board that repealing Town Law 3 of 2006, and accepting county jurisdiction and enforcement of dog control issues will result in better service coverage at reasonable cost to Kendall.

PUBLIC COMMENT

Mr. Michael O'Mara, Kenmor Road and Roosevelt Highway – asked if issues with dogs defecating on properties will be addressed in this county ordinance.

Supervisor Cammarata said there will be increased service coverage, both in hours and in days. Councilwoman Szozda read the paragraph of the county law addressing this issue.

Mr. Kenneth DeRoller, Kendall Road - reiterated that additional coverage will be provided by the Sheriff's office to those towns agreeing to fall under the county ordinance.

With no one else wishing to speak, Supervisor Cammarata closed the Hearing at 7:15 p.m.

PUBLIC HEARING – LOCAL LAW 2 OF 2018 <u>A LOCAL LAW ESTABLISHING</u> PROPERTY TAX EXEMPTION FOR VETERANS

Opened at 7:15 p.m.

TOWN BOARD COMMENTS

Background and justification

This is a state offered exemption for certain cold war era veterans.

Overview and opinion

The Assessor and the Board are in favor of this exemption being extended.

PUBLIC COMMENT

Al Lofthouse, Center Road – asked if this was standard across towns.

Assessor Massey explained that this exemption has been applied for nearly ten years, and this proposed law simply extends without sunset the current exemption.

Mr. Lofthouse asked what percentage of Kendall is eligible for the exemption, since any exemption is made up for by other taxpayers, and wondered about impact.

Supervisor Cammarata did not know how many are eligible. Assessor Massey said this law will only make permanent the current exemption.

Harry Butler, Roosevelt Highway – asked for the definition of "Cold War Veteran." Councilman Martin said the criteria are listed in the law. Attorney Meier specified that the exemption is authorized by NYS Real Property Tax law, in which Cold War Veteran is defined.

Jonathan Gilman, Roosevelt Highway – said that where you go to ask about eligibility varies in answer. He went to Albion and Westfall Road and found the rules to be different from each other. Supervisor Cammarata said this pertains to Town of Kendall and Orleans County property taxes, not veterans' benefits.

Kenneth DeRoller, Kendall Road – said Orleans County assessed the impact of this exemption as it shifts tax burden and determined this is the right thing to continue.

With no further public comment brought forward, Supervisor Cammarata closed the Hearing at 7:30 p.m.

The regular meeting was opened at 7:30 p.m.

RESOLUTION 47-0218 WATER DISTRICT 7 BID FOR MATERIAL SUPPLY

Be it hereby resolved that the Kendall Town Board authorizes the Kendall Town Clerk to advertise for bids for material supply for Kendall Water District 7 (Norway Road). The advertisement for bids shall be provided by the Town Engineer, LaBella Associates, DPC, and once approval to bid is obtained from the funding agency, Rural Development, placed in the Town's official newspaper one time. The date and time of the bid opening shall be coordinated with the Town Engineer.
