**SUPERVISOR'S COMMENTS**

NYS DOT meetings regarding tree replacement in Water District 8 have not gone well, but progress in negotiations is being made. NYS Senator Robert Ortz has been helpful.

Lakefront issues continue to worsen, and change will take time. The IJC has new members.

Homeland Security has been able to intervene to obtain an aquadam for Ed Rose Shores, but there was a shift in the dam itself today. Lake issues have been time consuming.

## **RESOLUTIONS**

Councilwoman Flow made the following motion, seconded by Councilwoman Szozda:

### **RESOLUTION 58-0519 BUDGET TRANSFER**

Be it hereby resolved to reduce General Account Number A9040.80, Workers Compensation Insurance by \$268.22, and increase General Account A7550.40, Celebrations, \$268.22.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion passed.

Councilman Martin made the following motion, seconded by Councilwoman Flow:

### **RESOLUTION 59-0519 CANCELLING WORK SESSION JULY 2<sup>ND</sup>.**

Due to the Fourth of July Holiday, the work session scheduled for July 2<sup>nd</sup> at 7 p.m. will be cancelled. A legal notice is to be published announcing the cancellation in the Hamlin Herald and on the Town Clerk's board near the front entrance.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion passed.

Councilwoman Szozda made the following motion, seconded by Councilwoman Flow:

### **RESOLUTION 60-0519 OPPOSING NEW YORK STATE SENATE BILL 2837 AND ASSEMBLY BILL 2750 TO ENACT THE FARMWORKERS FAIR LABOR PRACTICES ACT**

WHEREAS, Agriculture is Orleans County's and the Town of Kendall's number one industry, with farms directly and indirectly providing valuable jobs, support of local businesses and are a critical component of our Town and Region's economy, and,

WHEREAS, farms must compete for workers in a tight labor market, they value and respect their employees and pay over minimum wage to retain their skilled workforce, and H2A employees have a choice to work in less restrictive states, increasing stress on a shrinking labor pool, and

WHEREAS, according to the USDA, 98 % of New York farms are family owned, and

WHEREAS, Senator Jessica Ramos and Assemblywoman Catherine Nolan introduced S2837 and A2750 which would, among other things, provide collective bargaining rights to farm workers and require overtime pay and it is advocacy groups asking for collective bargaining, not farmworkers, and

WHEREAS, farming is already a highly regulated industry in New York State, placing a further marketplace competitive disadvantage from surrounding states and Canada on growing food for New Yorkers, and

WHEREAS, animal agriculture requires a workforce to care for animals at all hours every day and crop vegetable and fruit farming require seasonal, climate sensitive and time sensitive planting and harvesting where the effects of a labor strike on a farm could destroy an entire year's worth of crops, render perishable food not edible and adversely affect the health and care of animals, and

WHEREAS, New York State minimum wage ranks among the top five in the country, minimum wage in upstate New York being currently \$3.85 higher than federal minimum wage and on average farm wages are well above minimum wage, and

WHEREAS, prices paid to farmers for milk and most crops produced in Orleans County and the Town of Kendall are set by market conditions which are out of farmers' control, and they therefore have no way to recoup added costs of production by increasing the prices of their products, and so proposed overtime will likely result in fewer hours for workers rather than increased pay, since current prices received for agricultural products at the farm level cannot justify overtime pay rates, and

WHEREAS, Town of Kendall farmers must compete in regional, national and global marketplaces and this legislation would place them at a greater competitive disadvantage, and

WHEREAS, family farming is already on the decline and the economic impact of these labor mandates will further reduce profitability and push further disincentive to continue family farming operations in New York State and the net effect of increasing agricultural cost solely on New York farms will simply be to drive farm families out of business or out of state, and

WHEREAS, agriculture provides and protects the Town of Kendall's open spaces and beautiful landscapes, which are in jeopardy of falling to development and non-agriculture use if added costs force farms out of business, and so, now, therefore, be it

RESOLVED, that the Town of Kendall Town Board does pause in its deliberations to oppose S2837 / A2750 based on loss of market place, agribusiness economic loss to farm communities and major loss of income and benefits to farm employees, and the Kendall Town Board hereby requests that our State Legislators take steps to defeat such legislation, and be it further

RESOLVED, that the Kendall Town Clerk shall forward a copy of this resolution to Governor Andrew Cuomo, Senator Robert Ort, Assemblyman Steve Hawley, NYSAT and all others deemed necessary and proper.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion passed.

Councilwoman Flow made the following motion, seconded by Councilwoman Szozda:

**RESOLUTION 61-0519 CALLING UPON PRESIDENT TRUMP TO IMMEDIATELY RESCIND PLAN 2014 AND BEGIN RENEGOTIATIONS WITH CANADA**

WHEREAS, Plan 2014 and the International Joint Commission have once again – like 2017 – failed to protect the residents and infrastructure of the Town of Kendall’s Lake Ontario shoreline from flooding, be it

RESOLVED, that the Town of Kendall calls upon President Trump to immediately rescind Plan 2014 and, be it further

RESOLVED, that the Town of Kendall calls upon President Trump to renegotiate a plan with Canada that would prevent or alleviate the high Lake Ontario water levels causing devastation of Town of Kendall residences and businesses and strain upon its government infrastructure. Also, be it

RESOLVED, that the Town of Kendall shall forward copies of this resolution to President Trump; Secretary of State Michael R. Pompeo; U.S. Rep. Chris Collins; U.S. Senator Charles E. Schumer; U.S. Senator Kirsten E. Gillibrand; International Joint Commissioner Jane L. Corwin as the U.S. chairwoman, and Robert C. Sisson and Lance V. Yohe as commissioners, Assemblyman Stephen Hawley, Senator Robert Ort and all others deemed necessary and proper.

Discussion: Supervisor Cammarata spoke strongly in favor of this resolution.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion passed.

Restoration landscaping of Creek Road – still is not done; the engineer has been contacted.

County cell tower – Kenmor Road site does not seem viable. A private property on Carr Road is being considered, but the attorney will look into whether private property can be used for the municipal tower.

Water District Eleven – possibility of no income surveys required because using 2015 census rather than 2010 results is to Kendall’s favor.
