

**TOWN OF KENDALL**  
**SPECIAL MEETING TO RECEIVE THE 2021 TENTATIVE BUDGET**

Meeting called to order at 7:19 p.m.

This meeting was held to receive the 2021 Tentative Budget, which is a compilation of the requests of Department Heads.

The Town Board will review the Tentative Budget, make any changes it deems necessary, and then approve that by resolution, at which point it becomes the Preliminary Budget. The Preliminary Budget will be made available to the public, and a public hearing will be held, after which further changes may be made, and adoption of the Final Budget will be done by resolution.

Councilwoman Flow expressed a desire to keep the budget below the tax cap if at all possible.

**OTHER BUSINESS**

Councilwoman Szozda made the following motion, which was seconded by Councilwoman Flow:

**RESOLUTION 100-1020 CORRECTING RESOLUTION 94-0920 REGARDING OUT OF DISTRICT WATER AGREEMENT**

Whereas RESOLUTION 94-0920 was approved with an error as to the town for which its agreement pertained, and

Whereas, the Town Board of Kendall wishes to correct and pursue the agreement for a resident to obtain out of district water, so now therefore, let the following replace and supersede RESOLUTION 94-0920:

**RESOLUTION APPROVING OUT OF DISTRICT USER AGREEMENT BETWEEN TOWN OF KENDALL RESIDENT AND THE TOWN OF CARLTON**

**RESOLVED**, that pursuant to the provisions of §198(3)(b) of the Town Law of the State of New York, the Kendall Town Board hereby consents to the Town of Carlton entering into an outside user agreement with the following owner of real property situated on the east side of Transit Road, which premises are contiguous to, or within 500 feet of, the boundaries of Carlton Water District \_\_\_\_\_, providing for the Town of Carlton to supply public water to the said property through the Town of Carlton water distribution system:

Owner: Brian J. Schomske  
Property Address: 2075 Transit Road  
Tax Account No.: 343000 31.-1-19.11

**FURTHER RESOLVED**, that the property owner shall acknowledge in such agreement that if the Town of Kendall establishes a water district in the future which includes the owner's property, the owner will be deemed to benefit from inclusion in that water district and they will be assessed a bond repayment charge.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Councilwoman Flow made the following motion, which was seconded by Councilwoman Szozda:

**RESOLUTION 101-1020 JCAP JUSTICE COURT GRANT APPLICATION**

Be it Resolved to authorize the Kendall Justice Department to apply for a Justice Court Assistance Program Grant in the 2020-2021 cycle, for up to \$30,000.

Supervisor Cammarata called for a vote, which resulted in all ayes, and declared the motion carried.

Discussion: Councilwoman Flow said the grant may be applied to getting the parking lot repaired.

A certified copy of this resolution will be given to Justice Kluth.

With no further business coming before the board, a motion to adjourn was made by Councilwoman Szozda, seconded by Councilman Newell, agreed upon by all, and the meeting adjourned at 7:27 p.m.
